#### **OVERVIEW OF PROFILE**

Assoc. Prof. Dr. Harmahinder Singh obtained his Bachelor of Laws (Honours) degree and Master of Laws degree from the University of London, United Kingdom in 1998 and 2002, respectively. His Doctor of Philosophy in Laws degree was obtained from the National University of Malaysia in 2020. He has served 20 years and 10 months (Dec 2004 to Oct 2025) in the legal education fraternity of which the last 16 years have been dedicated towards various academic and strategic leadership roles in Taylor's University, the top private University in Malaysia.

Before joining Taylor's University, Assoc. Prof. Dr. Harmahinder was a Senior Consultant in the Investment and Indirect Tax Practice at KPMG Malaysia and a Senior Lecturer at the INTI International University, Malaysia. Having joined Taylor's University in December 2008, Assoc. Prof. Dr. Harmahinder served in various academic and strategic leadership roles in the University. He has served as the Programme Director of the Taylor's-University of Reading Law Twinning Programme from October 2009 to April 2010 at Taylor's Law School, Deputy Dean of Taylor's Law School from May 2010 to June 2011 and from July 2011 was officially appointed as the Dean of Taylor's Law School. The focus of his career has been in academic leadership roles.

His teaching and research interests are primarily in the area of Land Law, Equity and Trusts, particularly constructive trusts as a tool against unauthorized gain in business transactions; Unjust Enrichment and Restitution, Purpose-Driven Legal Education; and Art as a tool to promote the layman's understanding of the law.
